 - (3) in respect of both matters, address whether the case being made by any of the Interveners is based on appeals or applications for review brought by any of them against decisions made by the Charity

Commission for Northern Ireland (the 'Commission') affecting one or more of them where the Tribunal has made a judicial determination in those cases and, if so, whether that affects the application of any of the Interveners to be joined as a party to the determination of the Reference by the Tribunal within the said provisions of the Act;

- 2. The Attorney-General, within the same time period, shall furnish to the Tribunal, draft Directions providing for:
 - (1) the creation of a hearing bundle for the determination of the Reference by the Tribunal;
 - (2) a time estimate for the duration of any such hearing (subject to whether any one or more of the Interveners are joined as a party to the determination of the Reference;
 - (3) a suggested window for any such hearing with a view to discussing same with any of the Interveners the Tribunal rules may be joined as a party along with the Attorney-General in the determination of the Reference;
 - (4) its submissions on whether any such hearing should be determined on the papers alone, or be determined remotely, by WebEx,or be determined in a face-to-face hearing (the last matter being determined by the Tribunal by reference to ongoing restrictions on such mode of hearing and space considerations).
- 3. The Attorney-General shall have permission to apply to the Tribunal for any further Directions.
