INTERIM DIRECTIONS

ISSUED BY THE MASTER

This Act which comes into force on the 2 October 2000 brings the provisions of the European Convention of Human Rights into force of domestic law in the United Kingdom. The Act places the responsibility on the domestic Court to place compliance with the Convention before adherence to domestic law.

The following changes to current practice will take effect from 2 October 2000 on:-

- No new cases will be accepted under Articles 95 and 96 of the 1981 Order Procedure for recovery of certain admitted debts - without a direction from the Master as these Articles are an infringement of the rights of such debtors under Article 6 of the Convention for want of due process.
- 2. **No warrant for arrest** of any person will issue without the express authorization of the Master. The actual warrant on its face will bear evidence of its judicial issue. The words *Issued by Order of the Master*, will appear on the document.
- 3. **No seizure of goods** will take place under Article 32 of the 1981 Order, which authorises the Office to seize the goods of the debtor's spouse, where it appears to the Office that the judgment debt relates to -
 - (i) goods obtained or services rendered; or
 - (ii) the rent of, or rates due in respect of the occupation of, premises;
 - for the general use or enjoyment of the debtor, his spouse and his dependents residing with him.
 - as this Article is an infringement of the rights of such spouse under Article 6 of the Convention for want of due process.
- 4. In the execution of all **Orders for Possession** of premises only those persons whose names appear on the Order as Defendants or Notice Parties shall be evicted from the property.
 - If it appears that there are others of full age (not infant children in the custody of one of the named defendants or party) in occupation of the property, no eviction of such persons will take place. In all such cases the officer/s involved should seek a direction from the Master as soon as the presence of such non-party is ascertained.
- All hearings before the Master, whether on an existing list or ex parte, are Public hearings unless the Master expressly directs that in the interests of Justice, any persons or the public are to be excluded from attending at any sitting. Consequently, as a matter of practice all persons who indicate that they are interested in any matter shall be allowed to sit in on the hearing.

The Daily List of cases for hearing shall be posted at 10 am in the morning of any day when there is a List of Cases listed for hearing before the Master in the Reception Area of the 7th Floor, so that all will be aware that these matters are being heard *in public*.
